## **Privacy Policy**

The Cyber-Range Network is a collaboration initiative created jointly from three EU funded projects: FORE-SIGHT, Cyber-MAR and SPIDER.

The aforementioned projects created the “Cyber-Range Network” having as main objectives:

- to promote collaboration and to facilitate exchange of knowledge among them;
- to showcase their respective project results to a wider audience;
- to perform joint dissemination activities;
- to improve awareness regarding cybersecurity preparedness and training.

The Cyber-Range Network (“we”, “us”) is committed to protecting and respecting your privacy. This Privacy Policy sets out the basis on which your personal data will be processed by us in connection with the organization of the joint webinar. Please read the following document carefully, to understand our views and practices regarding your personal data and how we will handle it. When you register to the joint webinar, these Privacy Policy provisions will apply to our processing of your personal data.

## **Purpose of Data Processing**

The joint webinar between the three EU projects aims to introduce the three projects along with their key objectives and the current progress, to present the concept of cyber-ranges as virtual training environments and how they can be used for cyber warfare as well as to



exchange views and hold an interactive and productive discussion with the webinar participants. The webinar will be audio and video recorded in order to document the participants' view on the issues raised during the Joint Webinar.

Taking into consideration the above, the Cyber-Range Network uses information held about you in the following ways:

- To send you organizational, connection and registration information about the Joint Webinar.
- To provide you with related material/information, as an outcome of this activity.
- To anonymously publish your contribution in the project's deliverables.
- To publish screenshots for dissemination purposes.

### ***Categories of data that will be stored***

If you consent to the processing of your personal data for the above-mentioned purposes, the categories of personal data that will be collected and stored in the Cyber-Range Network are:

- My prefix (mandatory)
- My first name (mandatory)
- My last name (mandatory)
- My email address (mandatory)
- My Job Title (mandatory)
- My company/organization (mandatory)
- My face (optional- If I have or choose to use my camera)
- My voice (mandatory)

The Cyber-Range Network will process the personal data of subjects according to the present statement and for the purposes declared herein.

### ***Exercise of your rights***

It is noted that according to the General Data Protection Regulation (Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016), you may exercise the following rights that derive from the Regulation:

- Right of access and right to rectification for inaccurate personal data.
- Right to erasure of personal data if they are not necessary for service provision.



- Right to restrict processing of your data.
- Right to object to the processing of your data.
- Right to data portability, namely, right to receive your data in a structured, commonly used, and machine-readable form so that they can be transferred to another data processor.
